# WLS Nominating and Board Education Committee Meeting – April 6, 2022

The meeting began at 6:02pm

Karen Kelley, Chair, opened the WLS Nominating and Board Education Committee meeting with discussion on the three WLS trustee districts whose terms expire December 31, 2022. District 9 Trustee Catherine Draper's fine service has reached the limit of two consecutive terms. Ms. Kelley and Terry Kirchner will be discussing new trustee candidates with Ms. Draper and the committee. District 2 Trustee Jonathan Marshall and District 12 Trustee Ms. Kelley have each served one term and are interested in serving a second term.

The next agenda item was the status of the online WLS Trustee Manual review. Mr. Kirchner reported he is continuing to review and update specific links and content of the Trustee Manual. The committee members agreed on the annual review of the Trustee Manual site and ongoing updating of the Trustee Manual so that is remains useful to WLS trustees.

The final agenda item was a discussion of the WLS Trustee Institutes. The Trustee Institutes will aim to provide an opportunity for WLS member library trustees to meet and talk about key issues and information involving members' libraries, such as construction related topics, and broader WLS issues in Westchester County, such as digital equity and inclusion. A potential 2022 Trustee Institute timeline and topics was presented by Mr. Kirchner. The timing has a June 1 launch date, plus possibly four more events in 2022. Subjects being considered include construction, community long-range/strategic planning, legislative advocacy and digital equity and inclusion. The goal is for the events to provide a mix of in-person and online participation, with some occurring in a hybrid in-person/online environment

Mr. Marshall supported the idea of holding hybrid meetings with virtual platforms for all meetings where possible in order to expand the attendance. WLS could be a leader in hybrid meetings and programs. Nishat Hydari also supported this approach.

WLS would be promoting the meetings to member library trustees and recommends that WLS trustees help to inform member libraries in their districts about the Trustee Institute meetings.

The next meeting is scheduled for Monday, May 23, 2022, at 11:00am.
