December 6, 2021

Having focused on trends and challenges at the last meeting, he reminded the committee members to keep these issues, as well as the newly crafted Overview, Mission and Vision statements, in mind as the committee reviews the WLS Strategic Goals 2022-2024 – Working Document that was distributed by Terry Kirchner.

The document identified three major goals:

- Promote Equity and Access
- Expand Community Engagement
- Renew and Enhance our Infrastructure

To start the discussion, Mr. Okelo brought forward two questions:

- 1. Do the 3 issues addressed in the document cover enough? Is it comprehensive enough?
- 2. Is the committee ready to engage in a serious discussion at this stage or do the members feel that they need more time?

The committee members indicated that they were ready to engage in a serious discussion and numerous enhancements to the document were reviewed. The following changes were to be included in a revised version of the document:

- Be more explicit about the importance of communication as a core element within each of the strategic goals, but also as an overriding value/activity that will consistently be addressed by WLS (better communication as an aspiration)
  - Clarify what WLS does and does not do in terms of our relationship with the member libraries
  - $\circ$   $\;$  Be more vocal about the work that WLS does and has done
  - Find ways to help WLS trustees to better communicate the role of WLS
- Edit the 2<sup>nd</sup> goal's heading:
  - Change from "Expand Community Engagement" to "Expand Community / Member Library / Partner Engagement
- Edit the 3<sup>rd</sup> goal's heading:
  - Change from "Renew and Enhance our Infrastructure" to "Update and Improve our Infrastructure"
