- ► Conduct business publicly and ethically;
- ▶Oversee Finances;
- ► Conform to applicable laws, regulations and decisions;
- ► Appoint/Approve Personnel;
- ▶Establish Policies;
- ▶Be an Advocate for the Library!
- ▶ Communicate openly with the Director.

WHAT IS AN EFFECTIVE DIRECTOR?

A trusted and well qualified individual who serves as the Chief Executive Officer of the Library, ably fulfilling the Library's mission on a day to day basis.

The Director maintains a relationship with the Board that is fair, equitable for each trustee and effective for the Board as a whole, as well as for the staff and institution.

BASIC DIRECTOR RESPONSIBILITIES

- ▶ Manages Library operations and staff;
- ►Implements policies set by the Board;
- ► Selects personnel;
- ▶ Recommends programs & services;
- ▶ Responds to the Board's need for information;
- ▶ Is an Advocate for the Library;
- ► Communicates frequently with the Board.
